When this court has granted discretionary review on the State's application, it has not been constrained to make the arguments that the State requested it to make on original application. Instead, we have followed our common-law discretionary review practice of requiring the State to address any issues that had been presented to the court of appeals and would have been grounds for discretionary review on original application. That the State did not address any other grounds is not "unfair" to appellant, and it is not necessarily contrary to our practice. The dissent also suggests that this court's discretionary review procedure leads to "virtually no review of the findings made at the pretrial motion-to-suppress hearing." Post, at 6. But, without explicit statutory authority, this court has not historically provided for interlocutory review of the denial of a motion to suppress. Nonetheless, we have reviewed such denials for fundamental error because in those cases we may not exercise any discretion *794 to consider the merits of the issue at a later time. This is such a case. As stated above, appellant complains that his proposed amendment was not allowed because it sought to challenge the credibility of an informant. He also complains that the trial court failed to make any findings of fact on the credibility of the informant, and that the court of appeals erred by considering and rejecting the merits of this complaint in its opinion. In considering the merits of the amendment, the court of appeals noted that "[w]hile Appellant asserts, in general terms, that the State must prove that it has a confidential informant, he fails to show that he was prejudiced by the court's ruling and no findings of fact are required." State v. York, 871 S.W.2d at 283-84. In assessing the merits of appellant's points on appeal, the court of appeals did not review the trial court's denial of the motion to suppress. It considered only the ground raised by the amendment in reviewing whether the trial court erred in not allowing the amendment. The court of appeals did not resolve the credibility issue nor did it make any findings of fact. It made an independent evaluation of the merits of the 3da54e8ca3
